Military/Veterans Behavioral Health Emphasis Option

Students in both the online and on-ground CMHC modalities can elect an "Emphasis in Military/Veterans Behavioral Health". This Emphasis requires two courses taken in partnership with our Military Psychology department. The number of credit hours for the CMHC+Emphasis Degree are the same, at 62 credit hours.

Doctor of Psychology in Clinical Psychology, (Psy.D.) - Chicago Campus

Child and Adolescent Clinical Psychology Emphasis, (Psy.D.)

Emphasis Overview

This emphasis within our clinical psychology program provides focused coursework, training, and mentorship that prepare students as clinical psychologists with the necessary knowledge, skills, and training to work with children, adolescents, young adults and their families, and the issues that impact their mental health and well-being. Through the emphasis, our students gain innovative research- and practice-based understanding and skills related to assessment and intervention methods that are most appropriate to youth as well as understanding of the broader structural, systemic, and sociocultural factors that affect healthy development of children and adolescent health and development. These effects can be both barriers and resiliency factors in what fosters thriving wellness in an ever-changing world.

Child and adolescent psychologists work in a range of settings with young people and their families. With social justice and championing the rights of young people in mind, they conduct formal diagnostic assessments, provide psychotherapy and other therapeutic services, develop community-based youth programs, lead prevention initiatives, provide consultation, advocate for policy and more. Students are trained as practitioners with broad knowledge and specific skills in assessment, theory, research, and practice by faculty who are practicing clinicians as well as leading scholars, researchers, and educators with extensive child, adolescent, and family treatment experience.

Admission Criteria and Continued Enrollment

Students are admitted into the emphasis after successful completion of their first year in the program. Emphasis Admission criteria include:

• Admission into the emphasis requires an overall grade point average of at least 3.25 and passing all program milestones in your first year of the program.

- Submission of the emphasis application (more detailed information and instructions will be provided to by the end of spring semester of your first year regarding your submission).
- An Interview with the emphasis coordinator (group interview offerings will be available spring and summer semester before registration for your second year).
- Entry into the emphasis will be confirmed when an email invitation is accepted to join
 the child and adolescent emphasis canvas page. Special Note: Without accepting
 the invitation to the emphasis page, you will not be registered as being in the
 emphasis.
- Special Note: Admission to the emphasis is not guaranteed. The decision will be weighed in conjunction with other data.

Academic and Research Requirements:

Additionally, your dissertation project **must** involve research that contributes to developmental psychology, lifespan development, child psychology, adolescent mental health, and/or family-based health. The subjects or participants in your research do not have to be children or adolescents but must contribute to the above-mentioned in some way.

- Your dissertation topic must be approved by the emphasis coordinator by the second week in spring semester of your third year in the program (a link will be sent via the child and adolescent emphasis resource page)
- The emphasis coordinator does not need to be chair of your dissertation, but at least one member of your committee should be an expert or specialist in youth mental health or related fields (i.e., developmental psychology, primary care and family health, pediatrics, perinatal mental health).

Emphasis Training Requirements:

During your tenure in the program, **at least one** of your training practicums should be at a site focused on child, adolescent, or family-based treatment.

Emphasis Completion:

For successful completion of the child and adolescent psychology emphasis and have the emphasis listed on your degree, the following must occur:

- Satisfactory completion of all required credit hours for the program and those outlined in the emphasis course requirements above.
- Satisfactory completion of all training expectations, including social justice
 practicum and clinical practicum training and competencies (receiving credit for
 passing practicums successfully and receiving credit for passing clinical qualifying
 examinations)
- A cumulative grade point average of 3.25 or higher and no failing courses.
- Successful completion of a **dissertation** (that meets the research requirements listed above) and submission to the Psy.D. department.
- A submitted and approved checklist form to the emphasis coordinator (this will be available once you are part of the emphasis).

• Submission of completed graduation application, full payment of all outstanding tuition and fees, along with **degree conferral**, preparation for graduation.

Master of Psychology – Health & Wellness (MOPHW)

Program Overview

The Adler University Master of Psychology in Health and Wellness (MOPHW) is a 36-credit, specialized nonclinical degree that prepares professionals for leadership roles that enhance health outcomes.

As one of the only programs of its kind in Canada, this cutting-edge master's program goes beyond theory, providing students with hands-on expertise in psychometric assessment, wellness program design, and evidence-based leadership — equipping them to challenge the status quo, implementing innovative solutions, shaping policy, and leading efforts that drive lasting change in health care, public health, and community organizations.

Rooted in the biopsychosocial model of human growth and development, the curriculum trains students to assess population health needs and design evidence-based, sustainable interventions informed by research, health promotion, neurobiology, and cognition. It also aligns with many of the standards set by key professional organizations, including the Canadian Psychological Association (CPA), American Psychological Association (APA) Division 38 (Health Psychology), and the Society for Public Health Education (SOPHE).

Expert faculty mentorship and immersive learning experiences empower students to translate psychological research into practice. Graduates are equipped to navigate complex health challenges with confidence, developing strategies that enhance resilience and well-being at both individual and community levels.

Admission Requirements

At Adler University, students represent a wide range of professional interests, backgrounds, and academic and work histories. We admit individuals with a strong record of academic achievement and a commitment to social responsibility.

Applicants to the program must have the following:

- A baccalaureate degree or equivalent from an accredited institution.
- A GPA of 3.0 or higher for all undergraduate or graduate coursework.
- 92 or better on the Internet-based TOEFL (iBT) with no band lower than 22.
- 7.0 IELTS overall with no bands below 6.5.
- PTE must have a minimum score of 62.

Applicants are required to submit the following items to be considered for admission:

- Application and application fee.
- Statement of Intent answering the following questions:

Please respond to the following questions in your Statement of Intent letter. Your letter should be coherent, well-organized and reflect your voice and experiences. This is your opportunity to demonstrate your passion for psychology and suitability for the Adler University master's program. Ensure your letter is double-spaced, does not exceed three (3) pages, and please use "headings" so that you answer each question.

Who are you, and where do you come from?

Describe your background, including where you grew up and any significant personal experiences, family influences, or cultural factors shaping your interest in psychology.

What ignited your passion for psychology?

Discuss a specific event, experience, or realization that sparked your interest in psychology. Include any relevant coursework, research, volunteer work, or personal experiences that have further fueled your passion for the field.

Why are you interested in the master's program at Adler University?
 Explain why you are specifically interested in the master's program you are applying for at Adler University.

Where do you see yourself in future practice?

Describe your career aspirations and how you plan to apply your degree in your future career. Whether it be in consulting, research, teaching, or another area within psychology, explain how you intend to make a positive impact on the lives of others.

 Personal Reflection: What is your greatest strength and area for improvement, academically and professionally?

Reflect on your greatest strength and your area for academic and professional development. Provide specific examples that highlight these aspects of your development.

The following items are also required as part of the application process.

- Resume or Curriculum Vitae.
- Official transcripts from all undergraduate and graduate schools attended (U.S and Canada)

Transcripts should be sent directly to the Office of Admissions.

Unofficial transcripts are accepted for any schools in which a degree was not received.

 Applicants with international (outside the U.S. or Canada) post-secondary education should send a scan of their official transcript to the <u>Office of Admissions office</u> as this program is exempt from the requirement to complete a transcript evaluation. Please speak to your admissions advisor if you require more details.

All applicants who meet the minimum requirements in (1) and (2) will be required to interview with a program representative. Applicants will be assessed on their academic background, work and/or volunteer experience, fit with University mission, and the program of interest. Based on the interview, the decision will be (a) direct admission to the graduate program of interest or (b) denied admission.

*Applicants submitting admission documents (transcripts, bank documents, English proficiency scores, etc.) that are found to have been altered or fabricated will be denied admission. Denials based on fraudulent documents cannot be appealed.

International Applicants

Applicants with international (outside the U.S. or Canada) post-secondary education should send a scan of their official transcript to the admissions office as this program is exempt from the requirement to complete a transcript evaluation. Please speak to your admissions adviser if you require more details.

Applicants submitting admission documents (transcripts, bank documents, English proficiency scores, etc.) that are found to have been altered or fabricated will be denied admission. Denials based on fraudulent documents cannot be appealed.

International students must have a:

- Minimum score in one of the following English proficiency tests:
 - 92 or better on the IBT (Internet-based TOEFL).
 - 6.5 IELTS in all bands; overall IELTS of 7.0
 - o PTE must have a minimum score of 62.
- Statement of intent.
- Resume indicating related experience.

All applicants who meet the minimum requirements in (1) and (2) will be required to interview with a program representative. Applicants will be assessed on their academic background, work and/or volunteer experience, and fit with the University mission and program of interest. Based on the interview, the decision will be (a) admission to the graduate program of interest (MOPHW)or (b) denied admission.

Practicum - Vancouver Campus

Social Justice Practicum (SJP)

In their first year of the MOPHW program, students will spend approximately eight to 10 hours per week over the course of six months at an approved Social Justice Practicum (SJP) site and must concurrently enroll in required coursework. A minimum of 200 hours of SJP is required. For more information, students should contact the manager of community action and engagement, Vancouver Campus.

Graduation Requirements

- 1. Satisfactory completion of 36 credit hours, including all required courses.
- Satisfactory completion of 200 hours of the Social Justice Practicum.
- 3. A cumulative GPA of 3.5 or higher, and no more than two courses or six credits with a final grade of C.
- 4. Successful completion of the MOPHW Capstone.
- 5. Submission of completed graduation application and full payment of all outstanding tuition and fees.
